

THE JOHNSONVILLE CORNHOLE BOARD TEXT TO WIN SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Johnsonville Cornhole Board Text To Win Sweepstakes ("Sweepstakes") is sponsored by Johnsonville, LLC ("Sponsor"), N6928 Johnsonville Way, Sheboygan Falls, WI 53085 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on September 1, 2020 at 12:00 PM Eastern Time ("ET") and ends on October 31, 2020 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Price Chopper, Food Lion, Southeastern Grocers, HEB, Brookshire Grocery Company, United Food Stores, Tom Thumb, Albertson's Company Texas, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, there are two (2) ways to enter:
 - A. **Text Message:** Using an SMS-enabled mobile device, an entrant must send a text message to the short code "87963" ("Short Code") stating one (1) of the following keywords "SAUSAGE", "TAILGATE", "BACKYARD", "GRILLING", "CORNHOLE", "GRILL", "SIZZLE", BRATS", or "PLAYCORNHOLE" (each a "Keyword"). Once the text message is received, the entrant will be sent a reply text message asking the entrant to agree to these Official Rules. Entrants will only receive this reply text message after the first entry is received. Upon receipt of a valid Keyword and with respect to the first entry only, upon Sponsor's receipt of entrant's reply text agreeing to these Official Rules, an entrant will automatically receive one (1) entry into the pool ("Pool") for the respective Keyword and one (1) entry into the grand prize drawing ("Text Message Entry"). Only Text Message Entries to the Short Code with the valid Keyword, will be accepted as a valid Text Message Entry. See Section 6 ("How to Claim a Prize") regarding how potential winners will be notified. All Text Message Entries must be received by Sponsor or its authorized designee by 11:59:59 PM ET on October 31, 2020. NOTE: Proof of text message submission does not constitute proof of delivery or receipt of the text message.

IMPORTANT: Message and data rates may apply for each text message sent or received. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider's pricing plans. By texting the Keyword to the Short

Code, you provide to the Sponsor and Administrator your express written consent for you to receive text messages using automated technology in response to your entry related to the Sweepstakes. Consent to receive text messages is not required or a condition of any purchase. An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP" and the Keyword to the Short Code. If an entrant sends an opt-out text message, he/she will be sent a reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. For help, text the word "HELP" and the Keyword to the Short Code. Each Text Message Entry must be manually key-stroked/entered by the entrant.

- B. Mail-In Entry:** An eligible entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, date of birth, and one (1) of the Keywords listed above on a 3½"x5" card ("Mail-In Entry") and mail it with sufficient postage to: The Johnsonville Cornhole Board Text To Win Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked no later than October 31, 2020, and received on or before November 10, 2020, in order to be eligible. Entrant will receive (1) entry into the Pool based on the Keyword on his/her Mail-In Entry and one (1) entry into the grand prize drawing.

Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries mailed in an envelope or sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Entry Limit: Regardless of the method of entry, there is a limit of one (1) entry per person per day during the entire Sweepstakes Period. Limits on Mail-In entries will be based on postmark date, not received date. If more than one (1) entry is received from the same person, telephone number and/or e-mail address in a single day, only the first entry received may be considered valid. A "day" is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM CT on a calendar day during the Sweepstakes Period, except on September 1, 2020 when a day is defined as starting at 12:00 PM (noon) ET and ending at 11:59:59 PM ET.

- 4. RANDOM DRAWING:** On or about November 11, 2020, the Administrator will randomly select a total of two hundred (200) potential first prize winners (see chart in Section 5B for the number of potential winners selected per Pool) from among all eligible entries received for each Pool and one (1) potential grand prize winner from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

- A. Grand Prize (1):** The grand prize is sausage for a year awarded as nineteen (19) coupons each good for one (1) free Johnsonville product ("Grand Prize"). Coupons will be sent at different times. No more than one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$75.
- B. First Prizes (200 total):** Each first prize is a cornhole board (each a "First Prize"). No more than two hundred (200) First Prizes will be available in the Sweepstakes awarded amongst the Pools as follows:

C. Total ARV: The total ARV of the prizes is \$60,075.

D. Odds of Winning: The odds of winning the Grand Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period. The odds of winning a First Prize depend on the number of eligible Sweepstakes entries received for each Pool.

E. General Conditions: There is a limit of one (1) prize per household. Details of each Prize determined by Sponsor in its sole discretion. In no event will more than one (1) Grand Prize and two hundred (200) First Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winner via telephone or e-mail at the telephone number or e-mail address provided at the time of entry with instructions on how to claim his/her prize. Failure to provide all required information within the stated time period may result in forfeiture of a winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a prize, the respective prize may be forfeited. If a prize is forfeited, the prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Sponsor's sole and absolute discretion. consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents (“Released Parties”) are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner. VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
